#### \*\*\*\*New 2<sup>nd</sup> Indoor Pool Opening Soon\*\*\*\*

Construction of the new warm water pool began in July of 2015 and is estimated to be completed spring 2016. The new pool will be 20 yards long and 28 feet wide. Depth will range from 3½ feet to 4 feet, 8 inches. The warm-water pool was designed to accommodate water aerobics classes and children, which means adult lap swimmers soon won't have to continue to share the existing saltwater pool inside the upscale fitness center in Fairfax. The existing indoor pool, which has three wide lap lines and opened in 1990 along with the Sports Club, was converted to saltwater in 2011. The existing 25-yard indoor pool will be designated solely for lap swimming. This change will provide lap swimmers greater convenience and ease of use at all times of operation, as scheduled water activities will no longer hinder open use of the facility when members need it most.

# VILLAGE RENEWS CONTRACT WITH **RUMPKE**

#### New Recycling Contract Established

The Village of Fairfax participates in the Southwest Ohio Regional Refuse and Trash Association (SORRTA) along with several other Hamilton County municipalities. By going out on a joint bid, we are able to realize cost savings by having waste haulers bid on a single contract with thousands of more households than the Village could do on their own.

The consortium went out to bid in October, and a contact was recently awarded to Rumpke, who is the current waste and recycling hauler for the Village. The new contract takes effect on Tuesday March 1, 2016.

The Village had tried to negotiate a new pick-up day, Monday, but this was not able to be accomplished due to Rumpke's fleet availabilities. Trash and recycling pick-up will remain on Tuesdays. The Village will continue to work with Rumpke in the future to see if this date can be changed, but it will remain on Tuesdays for the foreseeable future.

The biggest change on this contract will be that as of March 2016, recycling will be picked up on an every-other-week basis. Each resident will receive a larger 65-gallon recycling bin with lid. This bin equals almost four of the red bins. You may keep your red bin for personal use or also place it on the curb for recycling if your 65-gallon bin gets full. The new carts will be delivered to each resident by Rumpke the first week of March. Recycling pick up will begin Tuesday March 8, 2016.

All residents will be receiving a mailer from Rumpke that will contain a calendar showing each of the dates recycling will be picked up in 2016. Although the Village strongly encourages each resident to recycle, if a resident wishes to opt out of receiving a larger recycling cart, the mailer will contain information on how to do that.

If you are a resident that already has a 65-gallon recycling cart from Rumpke, you will not receive a new one unless you specifically request a second cart. You will receive a bill from Rumpke through February 2016 and will no longer be billed. If you request a second cart, you will be billed for that as you are now.

# GAS METER INSPECTIONS

COMING

Beginning in February and through May of this year, Duke Energy will be performing inspections on gas metering equipment and piping located inside buildings in this area. The inspections will involve the gas piping from the building wall to the outlet of the gas meter to check for leakage and corrosion. On average, an inspection should take approximately ten minutes to complete.

Duke Energy has contacted with Southern Cross, Inc. to complete these inspections at residents and businesses with inside gas meters. The Southern Cross technician will be readily identifiable by wearing a visible Southern Cross ID picture ID as well as having a contact number for the customer to call for verification of the Duke Energy Ohio inspection. They will be driving a Southern Cross vehicle.

#### (TAX ARTICLE CONTINUED)

DO NOT include "1099-R Income". This form reports a distribution from a pension, 401-K, etc. when you change employers, or make a withdrawal from a retirement plan.

Tax Paid Other City, Village on line 5c. Credit for Tax Paid to Other Communities, <u>can only be up to 1.75%</u> of any wages taxable to Fairfax and taxed by the other community.

Your W-2 should show the amount of wages taxed by each city, how much local tax was paid and to which city the tax was paid.

If tax is paid to other city at a rate lower than 1.75%, the difference is due to the Village of Fairfax.

For local taxes paid directly to another municipality (not shown on your W-2), provide a copy of your tax return filed with the other community. No credit can be given without this or other verification.

No credit is given for "county tax"

More detailed instructions and examples are on the reverse of the tax return.

Joint returns: A husband and wife may file a joint return even if they filed separately on their State and Federal returns. *If a wife uses her maiden* name please indicate that on the form.

Estimated Tax for 2016: Estimated tax due quarterly on any estimated liability of "\$200.00" or more. NEW Quarterly Due Dates: 1<sup>st</sup> quarter due with April return; 2<sup>nd</sup> quarter due June 15<sup>th</sup>;  $3^{rd}$  quarter due Sept. 15<sup>th</sup>; 4<sup>th</sup> quarter Dec. 15<sup>th</sup> to avoid interest charge. The estimated tax form is on our website www.fairfaxoh.org or call 527-6506 to have a form mailed to you.

HRS: 8:30AM to 5:00 PM, Mon.- Fri. closed for lunch Appointments 5:00 - 6:00PM

Business Tax Returns are due April 18<sup>th</sup>, 2016 if operating on a calendar year or 4 months after the close of any fiscal year, unless an extension is submitted to the Village of Fairfax. When filing include a copy of the Federal Tax Return filed by your company/business and attach supporting schedules for items added or deducted on Fairfax schedule X, (reverse side of our return). Sole proprietors may file on an "Individual Return" and attach Federal Schedule C.

Withholding on Employee Wages: Earnings Tax of 1.75% must be deducted by each employer on all wages earned in the Village of Fairfax. Employee Withholding is submitted quarterly and is due 15 days after the close of each calendar quarter beginning in 2016.

Annual Reconciliation of Withholding is due February 28 of each year. You must attach W-2's or computer print out giving the same information for each employee and copies of any 1099 Misc. forms issued for work done in the Village of Fairfax. See form for all filing requirements.

\*\*\*\*\* TAX TIPS AND TOPICS

#### \*\*\*\*\*

The purpose of this article is to provide you with a quick overview of Village of Fairfax Earnings Tax Requirements. Not all regulations/policies can be covered here.

## 2015 TAX RETURNS for VILLAGE of FAIRFAX

All residents, 18 years or older must file a tax return with the Village of Fairfax, even if no tax is due. This includes those who rent. Taxes are based on an individual's earned income. Owners of rental property must also file a return. Withholding tax is required for employees working in the Village of Fairfax including those less than 18 years of age.

Account Numbers are 3 - 5 digits. Social Security numbers won't appear on tax forms.

TAX RATE: 1.75% for 2015 Returns and the 2016 estimated tax.

DUE DATE: 1) Resident and individual 2015 tax returns are due "April 18th, 2016" (to comply with federal due date). 2) Business tax returns also due "April 18th, 2016" if operating on a calendar year or 4 months after the close of a fiscal year. "Extensions also are due April 18th, 2016 and are for filing the return NOT payment of tax." If you file an extension with Fairfax, you must pay 90% of any 2015 estimated tax liability by April 18th, 2016 avoid interest/penalty.

**OBTAINING FORMS:** 1) Forms are available in the lobby of the Municipal Building 9:00AM - 5:00PM Monday - Friday. 2) January of each year tax forms are mailed to registered residents and businesses of the Village. However not receiving a form does not excuse anyone from filing a tax return. 3) Tax forms and instructions also are on our website www.fairfaxoh.org.

**REGISTRATION:** New residents or if you moved since filing your last tax return, you must register by mail or phone (Tax Office at 513-527-6506). Give name, address, SS#, date moved in and landlord's name if applicable. If registering by phone, please spell all names.

Tax due or refunds of less than THREE DOLLARS (\$3.00) shall not be collected or refunded.

### **TIPS FOR FILING YOUR FAIRFAX 2015 TAX RETURN**

Residents: "Qualifying Wages" on line 1. This total will not always be the same as the amount reported on your Federal Tax Return. \*Cafeteria plans are not taxed.\* Use the Medicare wages box 5, when adding the W-2 income. Deferred compensation such as 401-K plans, pension plans etc. are still subject to Village of Fairfax Earnings Tax. Add any taxable amounts in a box other than box 5, ei. sick pay. \*\*Include original W-2 from all employers. (Please make a note if you need the original W-2 returned, and we will mail it back after we review your return.)\*\*

#### Other Taxable Income on line 2.

Complete lines 13 - 19 on the reverse of the tax return and attach the correct Federal form for verification of each item. Carry total to front, list on line 2a (loss/deduction) or 2b (profit). Include 1099 "Miscellaneous Income" forms issued by your employers.

Include Federal Schedule C for profit or loss from a business. This applies if you are self-employed or a sole proprietor. Include Federal Schedule E for any rental property that is "located in Village of Fairfax". Attach Schedule E even if no tax is due, loss carry forward is **4yrs**. unless exhausted.

Include Federal Form 2106, Employee Business Expense if you take this deduction on line 18A or line 2. Allowed only if expenses apply to income taxable to the Village of Fairfax.

NOTE: Unemployment Compensation received in 2015 will not be taxed this year.

DO NOT include interest or dividends from your savings or investments on the Fairfax Tax Return. Interest and dividends are "not" reported for municipal earnings tax.

# MENTAL HEALTH ISSUES AFFECTING OUR YOUTH

On January 11th, the Warrior Coalition was pleased to host Nancy Miller who spoke to the group about mental health issues affecting our youth. Nancy is a resident of Mariemont and founder of the Warrior Run, which commemorates the life of her husband, Jim, who died from suicide in 2008.

Since its creation in 2010, the Warrior Run has been a staunch supporter of the "Surviving the Teens" program at Children's Hospital. In 2014, The Warrior Run expanded its reach through the creation of the High School and College "Fitness Challenge". The goal of the Fitness Challenge is to encourage students to improve their physical and mental fitness and give back to the community by participating in the Warrior Run, volunteering in their community and ege. All funds raised by students go to create mental health programs at their instifundraising for their school or tution. Since its inception, the Warrior Run has raised ove \$350,000 dollars in support of these programs and has been instrumental in rais s about 20% of youth ages 13-18. In fact, half of all lifetime cases chool, abuse substances ath drop out of s and/ or end up in the i th ages 10-24. Annual death in y screening by pediatricians and parent nd interven
