## **RESOLUTION NO. R1-2025**

## MODIFYING THE COMPENSATION FOR THE POSITIONS OF CHIEF OF POLICE, LIEUTENANT, SERGEANT AND PATROL OFFICER OF THE POLICE FORCE

**WHEREAS,** the Council ("Council") of the Village of Fairfax, Ohio (the "Village") previously adopted Ordinance No. 10-2021, providing the work periods and compensation for the positions of Chief of Police, Lieutenant, Sergeant, and Patrol Officer of the Village Police Force; and

**WHEREAS**, Ordinance No. 10-2021 provides further that Council may change such compensation by subsequent resolution adopted from time-to-time; and

**WHEREAS,** Council subsequently modified such compensation in Resolution No. R1-2024; and

**WHEREAS**, it is necessary to revise such compensation promptly, in light of the Village's interest in timely and appropriate administration and pay for such positions;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Fairfax, State of Ohio that:

**SECTION I:** The Chief of Police shall be compensated as follows: (1) four thousand one hundred sixty one dollars and ninety cents (\$4,161.90) for each bi-weekly period during the first six months of service; (2) four thousand two hundred thirty eight dollars and eighty three cents (\$4,238.83) for each bi-weekly period during the remaining six months of the first year of service; (3) four thousand four hundred sixteen dollars and eleven cents (\$4,416.11) for each bi-weekly period after the first year of service has been completed.

**SECTION II**: Any person holding the position of Lieutenant on the Police Force of the Village of Fairfax shall be compensated as follows: (1) three thousand eight hundred thirty dollars and eighty cents (\$3,830.80) for each bi-weekly period during the first six months of service; (2) three thousand nine hundred seven dollars and seventy two cents (\$3,907.72) for each bi-weekly period during the next six months of service; (3) four thousand eighty four dollars and ninety eight cents (\$4,084.98) for each bi-weekly period after the first year of service has been completed.

**SECTION III:** Any person holding the position of Sergeant on the Police Force of the Village of Fairfax shall be compensated as follows: (1) three thousand four hundred ninety nine dollars and sixty nine cents (\$3,499.69) for each bi-weekly period during the first six months of service; (2) three thousand five hundred seventy six dollars and sixty one cents (\$3,576.61) for each bi-weekly period during the next six months of service; (3) three thousand seven hundred fifty three dollars and eighty eight cents (\$3,753.88) for each bi-weekly period after the first year of service has been completed.

**SECTION IV:** Any person holding the position of Patrol Officer as a Detective on the Police Force of the Village of Fairfax shall be compensated as follows: (1) three

thousand two hundred thirty dollars and forty five cents (\$3,230.45) for each bi-weekly period during the first six months of service; (2) three thousand three hundred seven dollars and thirty eight cents (\$3,307.38) for each bi-weekly period during the next six months of service; (3) three thousand four hundred twenty two dollars and seventy six cents (\$3,422.76) for each bi-weekly period after the first year of service has been completed.

**SECTION V**: Any person holding the position of Patrol Officer other than as a Detective on the Police Force of the Village of Fairfax shall be compensated as follows: (1) three thousand two hundred thirty dollars and forty five cents (\$3,230.45) for each biweekly period during the first six months of service; (2) three thousand three hundred seven dollars and thirty eight cents (\$3,307.38) for each bi-weekly period during the next six months of service; (3) three thousand four hundred twenty two dollars and seventy six cents (\$3,422.76) for each bi-weekly period after the first year of service has been completed.

**SECTION VI:** The foregoing compensation shall take effect as of the pay period beginning March 23, 2025. Until such time, the existing compensation provided by Resolution No. R1-2024 shall remain in effect. This Resolution does not alter any other provision of Ordinance No. 10-2021.
